NFS STOCK CERTIFICATE PROCEDURES

Representatives must comply with the following procedures when handling stock certificates:

- Reps are NOT allowed to take possession of certificates.
- Certificates should NOT be sent to AIC's Home Office.
- Clients should be instructed to mail certificates directly to NFS.
- Reps can assist in preparing and packaging certificates for clients to mail; however, clients must not leave certificates in the rep's possession.

PREPARING CERTIFICATES FOR DEPOSIT

Front of Certificate

1. Write Account # in the upper right hand corner. (See Example A)

Back of Certificate

- 1. Have owner(s) listed on the front of the certificate sign on the back of the certificate (as shown in Example B).
- 2. In the space after "do hereby irrevocably constitute and appoint" write **NFS LLC** . (See Example B)

You may also use a Stock Power in lieu of completing the back of a certificate. (See Example C)

ADDITIONAL PAPERWORK

- 1) LOA

 A Letter of Authorization is required when depositing a certificate into an account with a different registration than what is listed on the front of the certificate. LOA's must be signed by all owners listed on the certificate. (See Example D)
- 2) TRUST If the certificate is registered to a trust, a FULL copy of the trust must be included with the certificate when mailed to NFS.

ADDITIONAL PAPERWORK (cont.)

- 3) For deceased individuals, please call the Home Office for instructions. Requirements differ depending on the registration type.
- 4) If you are opening a new account at NFS in which to deposit certificates, the new account paperwork must be sent to the Home Office before the certificate is shipped. You must obtain an account number to put on the certificate.
